Mayor Lamb made an opening statement outlining the Purpose and Conduct of the Public Hearing.

- Notice was published in the March 17th & 31st, 2023 editions of the Banner.

Mayor Lamb reviewed the financial plan and answered questions.

- 1) Are there any plans to fix/replace sidewalks?
 - a. Confirmation that the sidewalk on Quebec near the hospital is in the plan
- 2) How many metres is the watermain loop on 3rd avenue?
 - a. Unknown by members present – plan being developed by utility dept and is being considered for 2025
- 3) Why is the pumper truck scheduled for replacement several years in a row?
 - a. This is ongoing and in the 5 year capital plan
- 4) Why do we spend money on beautification; it used to be done by volunteers

- a. Beautification has been done by contract for many years as volunteers are not as active as they were previously. We are in a 3 year contract and may consider reviewing this option at that time
- 5) Why are we paying a grant to cemeteries?
- a. We are currently in the process of re-forming a cemetery committee at which time, property maintenance and revenue will be looked into to ensure long term care of the cemetery
