

# RIVERDALE MUNICIPALITY BY-LAW 2024-04

\*\*\*\*\*

**BEING** a by-law to set indemnities for Mayor and Council members.

\*\*\*\*\*

**Whereas** Section 124(1) of *The Municipal Act* defines the following:

*"compensation" includes a fee, salary, wage or any payment for labour or services, however determined;*

*"expense" means an expense incurred by a member of a council or council committee in attending to municipal business, and includes automobile expenses or mileage, travel expenses, living expenses, registration and tuition fees, the costs of materials for a meeting, conference or course, out-of-pocket expenditures and any other expense provided for in a by-law passed under subsection (2);*

*"municipal business" means a duty or function that a member of a council or council committee is required to carry out under this or any Act or a by-law or resolution, and includes attending a meeting, conference or course of instruction that relates to municipal purposes;*

**And Whereas** Section 124(2) of *The Municipal Act* provides as follows:

*A council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,*

- (a) as compensation for attending to municipal business;*
- (b) for expenses incurred while attending to municipal business; and*
- (c) for any other purpose relating to municipal business that the council considers appropriate.*

And whereas Section 124(3) of *The Municipal Act* provides as follows:

*A member of a council or council committee may be paid and may accept an amount paid under a by-law passed under subsection (2).*

**Now Therefore** the council of Riverdale Municipality enacts as follows:

1. That the Mayor of Riverdale Municipality be paid an indemnity of Ten Thousand, Eight Hundred Dollars (\$10,800.00) per year and said indemnity be paid in equal payments of \$900.00 per month.
2. That each Councillor be paid an indemnity of Eight Thousand Four Hundred Dollars, (\$8,400.00) per year and said indemnity be paid in equal payments of \$700.00 per month.
4. That Council be paid for attending special council meetings or committee meetings outside of the Municipality as follows;
  - Up to 3.5 hours one hundred dollars (\$100.00)
  - Over 3.5 hours two hundred dollars (\$200.00)
5. That Council members be paid mileage traveling to and from Council and Committee meetings at the rate set by policy based on the shortest distance to the councillor's home.
6. That Council members and Council Committee members traveling to meetings outside the boundaries of the municipality on municipal business be paid as per Section 4 and expenses as per policy.
7. That all payments be authorized by resolution of Council.
8. That any Riverdale Municipality Council member(s) absent for more than three regularly scheduled Council meetings annually will have a \$200.00 penalty deducted from their monthly indemnity for each meeting they miss.

9. That By-Law 2015-04 is hereby repealed
