Being a policy to provide for the application of Dust Control

POLICY STATEMENT

The municipality will apply dust control to areas designated by the Council or Municipal Works on an annual basis and as per the current year’s budget. Any residents or property owners wishing to have dust control on the municipal road fronting their property will be required to apply for dust control through the municipality at their own cost.

1. The Municipality will post a notice in the local paper accepting requests for dust control for the upcoming season.
2. Applications and pre-payments are to be received by the Municipal office no later than the date specified in the advertisement.
3. Calcium application will be offered as follows:
 - a) 12’ x 300’ strip at a cost of \$257 + gst
 - b) 12’ x 500’ strip at a cost of \$430 + gst
 - c) 16’ x 300’ strip at a cost of \$340 + gst
 - d) 16’ x 500’ strip at a cost of \$570 + gst

*Includes \$10.00 admin fee

4. Calcium billed out will include a \$10.00 admin fee on total liters applied.

** Minimum Charges may apply **

Each strip will be charged at the rate listed until such time as the costs associated with calcium application are reviewed.

- e) The Municipality has the right to refund all pre-payments in the event that there are not enough requests for a truck load.

APPENDIX "A"

The following areas will be serviced by the municipality every 2 years or at its discretion.

- Taylor Road - East end curve at Redline
- Taylor Road - West end at Hydro station
- Chimo Beach - Daly Beach Road/Wahtopanah Drive
- Aspen Road - Curve at Rd 118W & Rd 70
- Aspen Road - Curve at Rd 70 & Aspen Road
- Road 120W - North of Highway 25
- Road 120W - South of Memorial Drive intersection

The following areas will be serviced by the municipality annually or at its discretion.

1500 Litre total for the following areas:

- Back Lane - 300 blk of 2nd Ave
- Back Lane - 500 blk of 2nd Ave
- Back Lane - 600 blk of 2nd Ave
- Back Lane - 400 blk of 3rd Ave
- Back Lane - 600 blk of 3rd Ave
