RIVERDALE MUNICIPALITY PUBLIC NOTICE

Regarding Special Service Proposal No. 01-17 For Collection of Waste (Garbage) and Recycling

PUBLIC NOTICE is hereby given pursuant to subsection 318(1) of *The Municipal Act*, that the Council of Riverdale Municipality has scheduled a public hearing in the Council Chamber, at Riverdale Municipal office in Rivers, Manitoba on the **7th day of March, 2017 at 7:00 P.M.** to present the following special service proposal:

Riverdale Municipality wishes to establish a special service levy to raise funds for the bi-weekly curbside collection of household waste and the bi-weekly collection of recycling from residences within the communities of Rivers, Wheatland, Chimo Beach resort, along #25 Highway from the East boundary of the community of Rivers to, and including Daly Beach Road north of Highway #25.

The Special Service Area to be levied under this proposal will be all taxable residential properties in three special service areas known as Rivers (Special Service Area 1), Wheatland (Special Service Area 2), and Chimo Beach Resort, along # 25 Highway from the East boundary of Rivers to, and including Daly Beach Road north of Highway # 25 (Special Service Area 3).

Riverdale Municipality will budget in 2017 to 2021 inclusive the following amounts for the services included in this proposal.

All SINGLE FAMILY DWELLINGS will pay the "R – Residential" Rate.

The aforementioned Special Service Tax will be set out in the Financial Plan for the years 2017 – 2021 inclusive.

A written objection may be filed with the Chief Administrative Officer at the Riverdale municipal office, 670 – 2nd Ave, prior to the commencement of the hearing. At the hearing, Council will hear any potential taxpayer who wishes to make a presentation, ask questions or register an objection to the special service proposal.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.

Copies of the special service proposal are available for review and may be examined by any person during regular office hours of the Riverdale Municipal Office at 670 – 2nd Avenue, Rivers, Manitoba.
